The committee will review the application and resume of potential candidates. They will then make contact with each candidate to make an assessment of their personal and professional integrity, as well as to assess their level of commitment to the organization, and availability.

Timeline:

- February 15th, Deadline to receive applications at the WUA office;
- February 16th, Election committee will contact each candidate to make an assessment of each candidate via a phone interview;
- February 19th, Voting ballots will be mailed out to WUA Members,
- February 28th, Deadline to receive ballots;
- March 2nd, Ballots are counted;
- March 5th, Elected Directors are contacted, and a board commitment letter is sent;
- March 12th, Candidates shall be declared and announced at the March Board meeting;
- April 9th, New Board Directors are seated at their first meeting.
