If you are selling merchants, including food, you **MUST** have a City of Whittier Business License. If you do not have a City of Whittier Business License, fill out the form with application. The City of Whittier offers a one day license at \$26.00 or annual license at \$61.00.

If you are selling food, you **MUST** obtain a Los Angeles County Health Permit under this event.
