**Vendor Rules & Regulations**

Advertisers and Food Vendors, request separate applications.

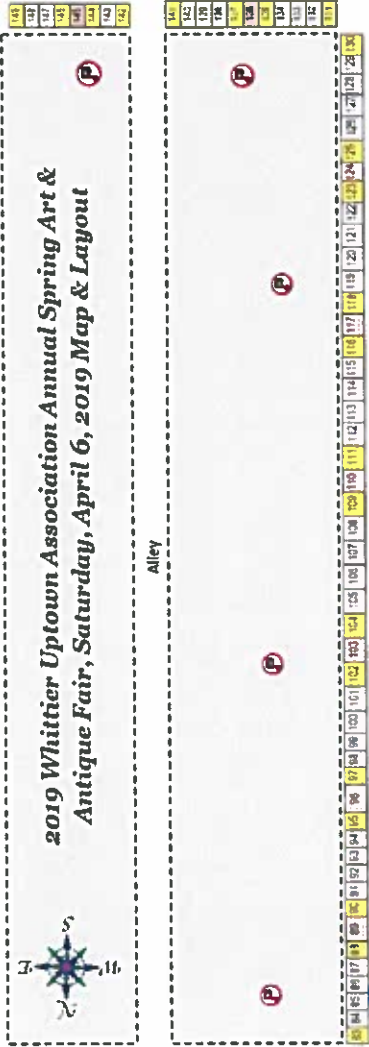
**Note: Due to new fire regulations, all booth spaces are arranged along the SIDE of the road.**

1. All vendor (Antique, Vintage, Art & Crafts) spaces are 11'x11'.  
Cost is \$60 per SINGLE 11'x11' space. Corner locations are \$80 each. One vendor per space.  
You must provide a copy of the required Whittier Business License - obtain through City of Whittier.  
Applications must be postmarked no later than March 8<sup>th</sup> or a \$25 additional rush processing fee will be added.
2. Vendors must supply their own canopy pop-up tent, tables, chairs, display, etc. Fee is for space only.
3. Merchandise rules and conditions.
  - a. ANTIQUE, VINTAGE, & COLLECTIBLE merchandise must be original, not reproductions (nothing after 1988.)  
NO junk! NO new reproduction merchandise! NO weapons, firearms, animals, food, or pornography!
  - b. ART, ARTISAN WARES, & HANDCRAFTS must be created by the vendor using original designs.  
NO imported goods. NO commercially manufactured goods. NO resale items. NO items assembled from kits.
4. Sellers, please DO NOT bring animals or pets to the show!
5. No radios or loud music allowed.
6. Rain or shine, the event will go on. No refunds/credits will be given under any circumstances. Sellers who do not show up will not be refunded their money. No sub-leasing or re-selling of space is allowed. NO EXCEPTIONS
7. Tasteful display presentation is encouraged. Sellers must supply their own table, chairs, and canopy.
8. Vendors agree to indemnify the Whittier Uptown Association, the City of Whittier, the Art & Antique Faire Committee and its staff against any and all actions (e.g., injury that may occur - personal or automobile or loss of property from fire, theft, malicious mischief, accident or other causes).
9. Sellers should move into their space between 6:00 – 8:00 am. All sellers must be in their space and vehicles removed by 8:30 am. Sellers will be denied vehicle entry after 8:00 am and lose their space after 9:00 am with no refunds. Official selling hours are 9:00 am to 3:00 pm.
10. Philadelphia Street will be reopened at 3:00 pm for move out. No vehicles may enter prior to this time. Sellers must not pack up their goods prior to 3:00 pm, as this will reduce the effectiveness of the street faire and is unfair to other sellers and buyers alike. All sellers must be packed and off the street by 4:30 pm. Streets will be reopened at 5:00 pm. Sellers must remove all merchandise, trash, and packing material brought in for sale. Failure to comply will result in a \$100 clean-up charge.
11. All sellers must bring a copy of their California Resale Sellers Permit, a copy of City of Whittier Business License, and original parking pass provided by WUA.
12. Deposit of payment does not constitute acceptance - if not accepted, a refund will be issued.
13. The Art & Antique Fair Committee reserves the right to add new rules and regulations if necessary and seller shall abide by such additional rules and regulations.
14. Vendor Parking areas: Vendors must park vehicles in designated areas. A parking map & pass will be provided.

**NOTE: You must include a copy of current seller's permit and a copy of City of Whittier Business License in order for your application to be processed. If you do not already have a seller's permit or business license, call for more information about how to obtain these.**
